Strip & Clean Water-Based Stripping Agent

- 1. Apply Strip & Clean to surfaces by conical tip sprayer. Make sure the surface is fully covered and allow Strip & Clean to work a minimum of 10 minutes.
- 2. After 10 minutes, scrub the surface using a brush or scrubbing machine.
- 3. After scrubbing, rinse the surface thoroughly with water and vacuum up to remove any surface material.
- 4. Make sure the remaining excess material is cleaned up before proceeding to apply other chemicals and colorants.

Cleanup

Rinse all equipment and applicators with water shortly after using Strip & Clean.

Storage

- Store upright in safe dry place at 40-100°F (4-38°C)
- Keep product from freezing
- Keep out of reach of children
- Seal container after use
- Do not mix with other chemicals
